Allegations about special cancellation

If the user has a special cancellation open pending of allegation, the user must access to our system www.dominios.es with the access password of domain name holder or the administrative contact associated with the domain.

Once the user has accessed to the system, from the left menu "My Requisitions" / "Pending Cancellation Procedures" they can access the list of special cancellation requests, as shown in the following image:


